Serving Recommendations:

Suggested serving plan for getting started with speak. Continue with established serving at 12 weeks and beyond:

* Start with 1 capsule of speak daily. After 2 weeks increase the serving to 2 capsules daily until reaching a possible serving of 6 capsules per day over 12 weeks and beyond.

- Begin with one speak capsule (1.5 mL) daily with food and increase slowly.
- Serving size for toddlers and smaller children typically ranges from 2 - 4 capsules/day (3 to 6 mL).
- Serving size for older and larger children typically ranges from 4 - 6 capsules/day (6 to 9 mL).
- It is recommended to administer speak for a minimum of 4 months.

Why is speak unique?

Omega-3 is found in many forms and combinations including high EFA, high EPA, and omega-3,6,9. While these may be beneficial for the general population, they do not contain the additional nutrients in doses and ratios specifically developed for the unique population of children with special nutritional requirements. The higher amounts of the two forms of vitamin E contained in speak are critical antioxidants working alongside omega-3 to support neurological health and provide essential nutrition. Vitamins K1 and K2 (natural blood coagulants) are included in the formulation for nutrient balance due to the theoretical blood thinning effects of omega-3 and vitamin E. Experts agree that vitamin D3 in certain populations is of particular importance and benefit and is included in the twists and Pure Oil.†

Each concentrated serving contains 725 mg EPA, 275 mg DHA omega-3s, 500 IU d-alpha tocopherol, 200 mg gamma tocopherol (vitamin E), 1.15 mg vitamin K (K1 and K2), and 60 mg GLA in the capsules while the twists and Pure Oil contain 800 IU vitamin D3.
